Incentive Zoning and MHA Adoption Timeline

Present – Early January 2019: The Office of Planning & Community Development will conduct additional environmental review to supplement the FEIS's historical resources analysis.

Early January 2019 – Mid-February 2019: MHA Select Committee will discuss proposed amendments (Councilmember Rob Johnson asked that amendments be submitted within the next five weeks).

Mid-February 2019 – Late February 2019: Public Hearing will be held on MHA city-wide legislation, proposed amendments, and Comprehensive Plan amendments.

Late February 2019 – Early March 2019: MHA Select Committee will vote on amendments and recommendation for final City Council action. Early March 2019 – Late March 2019: City Council will vote on MHA city-wide legislation.
